Sir/ Madam,

The Institute is organizing a "**Sensitization Programme on Prevention of Trafficking of Women and Children from 5 -7 September, 2018 at NIPCCD, Regional Centre, Indore**". The objectives of the programme are to: orient the participants to the nature and magnitude of trafficking of women and children; share and review constitutional provisions and legal framework to safeguarding women; discuss and analyze the role of Government and NGOs to address the problem of trafficking; and evolve a strategy for prevention, protection and rehabilitation of woman/child survivors of trafficking.

2. The participants of the programme will be senior and middle level officials of Government/ representatives of voluntary organizations associated with planning and implementation of the programmes and projects relating to welfare, development, protection and empowerment of women. You are requested to nominate a senior/ middle level official of your department / organization to participate in the programme.

The participants from NGOs who attended any training programme of the Institute in last two years and having educational qualifications below graduation may kindly not be nominated.

3. The participants from **NGOs** will be reimbursed travel grant up to AC III tier rail fare (excluding Rajdhani, Shatabdi, Duronto express and AC Bus) by the shortest route to and from venue of the programme. The journey by road to the nearest railway /bus station will be paid to the non-official participants as per NIPCCD norms. **In order to facilitate online payment of TA, the participants from NGOs are requested to bring their Accounts details including Name and Complete Address of their Bank, Account Number, IFS code, PAN Card Number and Aadhar Number. Officials deputed from Government departments will draw their TA/DA from their respective departments.** However the Institute will provide free board and lodging facilities to all the outstation participants at its hostel located at its premises in NIPCCD, Regional Centre, Indore for the duration of the programme and one day before and after the programme.

4. A nominal Registration Fee of Rs. 500/- (Rupees Five hundred only) will be charged from the representatives of voluntary organizations at the time of Registration on 05 September, 2018. Government Officials are exempted from the registration fee. It is requested that nomination in the enclosed proforma duly completed with a passport sized colour photograph, forwarded by Head of the Organization may be sent to the Institute at the earliest and latest by 20 August, 2018. यह संस्थान महिलाओं तथा बच्चों के अनैतिक व्यापार की रोकथाम पर निपसिड क्षेत्रीय केन्द्र इन्दौर, मध्यप्रदेश में 05-07 सितम्बर, 2018 तक एक सुग्राह्यता कार्यक्रम का आयोजन कर रहा है। इस कार्यक्रम के उद्देश्य ये हैं : सहभागियों को महिलाओं तथा बच्चों के अनैतिक व्यापार के स्वरूप और व्याप्ति के बारे में अवगत कराना; महिलाओं की सुरक्षा हेतु संवैधानिक प्रावधानों एवं कानूनी ढांचे की चर्चा व समीक्षा करना; अनैतिक व्यापार की समस्या की रोकथाम हेतु सरकारी तथा गैर-सरकारी संगठनों की भूमिका का विश्लेषण करना; तथा अनैतिक व्यापार की रोकथाम तथा अनैतिक व्यापार से बचाई गई महिलाओं/बच्चों के संरक्षण और पुनर्वास की रणनीति तैयार करना।

2. इस कार्यक्रम के सहभागी सरकार के वरिष्ठ तथा मध्यस्तरीय अधिकारी एवं गैर-सरकारी संगठनों के प्रतिनिधि जो कि महिलाओं के विकास एवं कल्याण से संबद्ध विभिन्न योजनाओं/कार्यक्रमों की आयोजना और कार्यान्वयन के कार्यों में संलग्न हो भाग लेंगे। अनुरोध है कि आप अपने संस्थान/विभाग के वरिष्ठ तथा मध्यस्तरीय अधिकारी को कार्यक्रम में भाग लेने के हेतु नामांकित करें। कृपया स्वैच्छिक संगठनों के उन प्रतिनिधियों, जिन्होंने इस संस्थान या इसके क्षेत्रीय केन्द्रों द्वारा पिछले दो वर्षों के दौरान आयोजित किसी प्रशिक्षण कार्यक्रम/कार्यशाला में भाग लिया है, तथा जिनकी शैक्षणिक योग्यता स्नातक से कम हों, उन्हें नामांकित न करें।

3. गैर-सरकारी संगठनों के सहभागियों को सबसे छोटे मार्ग से कार्यक्रम स्थल तक आने-जाने का एसी श्रु टीयर तक का रेल किराया (राजधानी, शताब्दी और दुरन्तो एक्सप्रेस तथा एसी बस/तत्काल को छोड़कर) दिया जायेगा। गैर-सरकारी सहभागियों को नजदीकी रेलवे स्टेशन/बस स्टेशन तक सड़क यात्रा पर दिए गए वास्तविक खर्च का भुगतान तथा स्थानीय सहभागियों को स्थानीय वाहन पर होने वाले वास्तविक खर्च का भुगतान संस्थान के नियमानुसार किया जाएगा, अतएव अनुरोध है कि यात्रा भुगतान हेतु आप अपने बैंक खाते संबंधित सूचना जैसे बैंक का नाम व पता, बैंक खाता संख्या, आई एफ एस कोड, पैन कार्ड संख्या एवं आधार कार्ड संख्या अपने साथ अवश्य लेकर आएं। सरकारी विभागों के अधिकारी यात्रा भत्ता/दैनिक भत्ता अपने-अपने कार्यालयों/विभागों से प्राप्त करेंगे। तथापि संस्थान कार्यक्रम की अवधि के दौरान बाहर से आने वाले सभी सहभागियों के भोजन और आवास की निःशुल्क व्यवस्था निपसिड क्षेत्रीय केन्द्र इन्दौर, मध्यप्रदेश स्थित अपने परिसर के छात्रावास में करेगा।

PROGRAMME DESIGN

Trafficking in human beings involves the transportation, harboring or receipt of persons by means of threat, coercion, abduction or fraud for the purpose of exploitation. The problem of human trafficking, particularly in women and children has emerged as grave social issue, as a vast majority (71percent) of all human trafficking victims are women and young girls (UNODC,2016). The gross commercialization and commodification of innocent human lives is like most serious affronts to the dignity of human rights; in fact it is not only about the violation of human rights but it is the defeat of human rights. Human trafficking, prohibited under Article 23 (1) of the Constitution, includes forced labour, sexual exploitation or prostitution, domestic servitude, forced marriage, begging, adoption, child pornography and organ transplant.

According to the **NCRB report**, a total of **8,132 human trafficking cases** were reported **in India in 2016** compared to the **6,877 cases in 2015**. **West Bengal topped the list** in reported cases of **human trafficking at 3,579**, accounting for 44% of total cases in the country. **Rajasthan with 1,422 (17.5%) cases was second on the list** for reported human trafficking incidents in **2016**, followed by **Gujarat (548), Maharashtra (517) and Tamil Nadu (434)**. Trafficking of women and children is a growing scourge carried out for various reasons such as sexual exploitation, bonded domestic labour, fraudulent marriages, sex tourism, organ trade, camel jockeying etc. This global violation of human rights occurs within countries and across borders, regions and continents. India has emerged as a source, destination and transit country for both in country and cross border trafficking. Poverty, low status of women, lack of a protective environment, etc. are some of the causes for trafficking.

The problem of trafficking of women and children for commercial sexual exploitation is especially challenging due to its myriad complexities and variations. Trafficking clearly violates the fundamental right to a life of dignity. It also violates the right to health and health care, liberty and security of person, and the right to freedom from torture, violence, cruelty or degrading treatment. In the existing social scenario in our country, vulnerability is a product of inequality, low status and discrimination as well as the patriarchal and captivating authority unleashed on children, especially the girl child. Moreover, despite various legislations and programmes, the situation is not improving.

The effects of trafficking, particularly on physical, emotional and psychological development of children are manifold and have serious repercussions. During the last decade, as more and more evidence has come to light, this issue is receiving serious level. Ministry of Women and Child Development, Government of India has been placing a special focus on this issue by implementing various programmes for prevention of trafficking of women and children

which includes "UJJAWALA" a comprehensive scheme for prevention of trafficking, with five specific components: Prevention, Rescue, Rehabilitation, Reintegration and Repatriation.

Needless to say, a multi-sectoral approach is needed which will undertake preventive measures to arrest trafficking, especially in vulnerable areas and among vulnerable sections of population; and to enable rescue, rehabilitation and reintegration of the trafficked victims. Hence, numerous interventions would be required at all levels of care. Interventions to curb women trafficking can be done at three levels: (a) the prevention of trafficking, (b) the protection of victims and (c) the prosecution of the traffickers. Further, more lack of awareness regarding the menace continues to be a major roadblock to prevent trafficking of women and Children. Therefore, there is a strong need to strengthen the knowledge and understanding of individual's about this serious and heinous crime, its effects on individuals, and the identification of useful strategies to control this inhuman act.

Prevention can be done through public awareness campaigns and by incorporating health and human trafficking information into existing programmes, policies, education and curricula. Therefore, it is realized that both Government and non- governmental institutions can together play an important role in combating trafficking, rescue and rehabilitation of trafficked victims. Keeping this in view, the Institute proposes to organize a **Sensitization Programme on Prevention of Trafficking of Women and Children from 05-07 September, 2018 at NIPCCD, Regional Centre Indore, Madhya Pradesh.**

Objectives: The main objectives of the programme will be to:

- i. orient the participants to the nature and magnitude of trafficking of women and children;
- ii. share and review constitutional provisions and legal framework to safeguarding women;
- iii. discuss and analyze the role of Government and NGOs to address the problem of trafficking; and
- iv. evolve a strategy for prevention, protection and rehabilitation of woman/child survivors of trafficking.

Course Content: The course contents will broadly cover: definition of trafficking; trends of trafficking of women and children in the country; legal safeguards; rescue and rehabilitation services; issues related to health, HIV/AIDs and trauma management; and schemes of MWCD related to trafficking and role of NGOs etc.

Methodology: The contents of the programme would be covered through a combination of training methods including lecture-cum-discussions; group discussions; case study analysis; group exercises; and films etc., with emphasis on participatory approach to learning.

Course Faculty: Besides the faculty of the Institute, the resource faculty will be drawn from government, non- governmental organizations, academic and technical institutions with relevant experience and expertise in the subject.

Participants: There will be 30-35 participants comprising senior and middle level officials of National and State Level Government (GO) and Non- Government Organizations from all over the country will attend the programme. **The participants for the programme will be selected on the basis of criteria which may include educational qualifications; work experience, regional/local representation, language skill etc.** The selection of the participants is purely discretionary and **will be decided by the competent authority of the Institute.**

Background Material: To supplement the classroom discussions the study material comprising of compendium of reading material, handouts and other informative material will be distributed to the participants during the programme.

Venue and Duration: The duration of the programme will be **of three days from 05-07 September, 2018** and it will be organized in the **National Institute of Public Cooperation and Child Development (NIPCCD), Regional Centre, Indore** (located at Bada Bagarda, Hathod Road, Gomat Giri, Opposite MPSEB Office, Indore-453112) Madhya Pradesh.

Registration Fee: While the Institute will continue to subsidize its programmes, it has been decided to charge a nominal registration fee of Rs. 500/- (Rupees five hundred only) per participant from all the participants representing NGOs at the time of Registration. **No registration fee will be charged from Government Officials.**

NGO-Partnership System Registration: The NGOs nominating their representatives are expected to have registered under the NGO Partnership System of NITI Ayog and furnish their Unique ID number in the nomination proforma.

Travel, Board and Lodging: The outstation participants from NGOs will be paid travel grant equivalent to AC III tier rail/actual bus fare by the shortest route to and from the venue of the programme (**excluding Shatabdi/ Durgam/ Rajdhani Express and AC Bus**). The journey by road to the nearest railway station/bus station will be paid to the non-official participants as per Institute's Rule. Local participants will be paid local conveyance as per Institute's Rule. **In order to facilitate online payment of TA, the participants from NGOs are requested to bring their Accounts details including Name and Complete Address of their Bank, Account Number, IFS code, PAN Card Number and Aadhar Number.** However, officials deputed from **Government departments, will draw their TA from their respective States/UTs.** The Institute will arrange free board and lodging facilities to all the outstation participants in its hostel located at its premises for the duration of the programme and one day before and one day after the programme.

General Instructions

1. The enclosed nomination form duly filled and sponsored by the competent authority of the organization/ department should reach the Institute at the earliest and latest by **20 August, 2018.** **A passport sized photograph should be affixed on the nomination form.** **The registration number obtained from Planning Commission is mandatory for considering the nomination.**

2. The participants are required to attend the programme for its entire duration. The Participants reporting late or leaving it before the concluding session would not be entitled for programme certificate or reimbursement of travel expenses.
3. **The participants are advised to proceed only after receiving the confirmation about their participation from the Institute.** In case of non- receipt of confirmation letter, they are requested to confirm their participation over telephone or via email before proceeding for the programme.
4. Confirmed Participants should report for the programme at **9.00 a.m. on 05 September, 2018 (Wednesday). The programme will conclude on 07 September, 2018 (Friday) at 5.30 p.m.**
5. Hostel accommodation will be available to the participants for the duration of the programmer and one day before and one day after the programme.
6. The Institute will have no responsibilities whatsoever towards board and lodging in respect of family members, relatives or friends of the participants. The Institute will not be able to take the responsibility of making reservation of the participants.
