During the deliberation in the Review Meet, it was discussed that some of the State Education Departments are doing some innovative work in respect of development of ECCE curriculum, development of teaching learning materials and training of ECCE workers. Therefore, it was suggested that coordination between ICDS and Education Department needs to be strengthened for effective implementation of Annual ECCE Curriculum in States/UTs.

XVII. Majority of the Nodal officials of States/UTs expressed concern over non-engagement of contractual staff under ICDS Mission in general and ECCE staff in particular. Non-deployment of these contractual staff is mostly due to non-approval of the State Finance Department. It was felt that the matter should be taken up with appropriate state authority for taking further necessary action for early deployment.

#### 7. CONCLUSION

The Valedictory Session of the Review Meet was held under the chairpersonship of Shri S.C. Srivastava, Joint Director (Public Cooperation and Child Development), NIPCCD in the afternoon of 23 February, 2017. The Session started with presentation of suggestions/recommendations emerged from the deliberations of the Review Meet. Some of the state officials also explained/clarified issues related to implementation of ECCE curriculum pertaining to recommendations. Some of the participants also suggested that one senior person from MWCD dealing with ECCE should be invited for such review meet. It was clarified that the Deputy Secretary (ECCE), MWCD was invited but due to some important pre-occupation, it was not possible for him to address the nodal officials in this Review Meet. Keeping in view the best interest of ECCE, it was decided that all the suggestions/recommendations of the Review Meet would be forwarded to MWCD for their consideration. As requested by the Nodal Officers, copy of the report of this Review Meet would be sent to all the States/UTs. It was also decided that such Review Meet on Implementation of Annual ECCE curriculum should be held annually.

discussed that these SLMTs may be provided with a need based refresher training.

- XII. For effective implementation of ECCE curriculum, it was discussed that ICDS functionaries (Supervisors, CDPOs and DPOs) need to be oriented on ECCE curriculum so that need based supervision and monitoring implementation of ECCE can be strengthened. Similarly, in order to strengthen the training input particularly in respect of AWWs and Supervisors, it was discussed that ICDS trainers (Instructors of AWTCs and MLTCs) need to be oriented on ECCE curriculum.
- XIII. Keeping in view the importance of monitoring implementation of ECCE curriculum and lack of guidelines/indicators developed by the State/UT, it was suggested that all the States/UTs need to develop brief guidelines for monitoring implementation of ECCE curriculum at AWC. State/UT may use the suggestive monitoring indicators already developed by ECCE Cell, NIPCCD and provided to SLMTs during their training, for development of need based monitoring indicators. If needed be, a copy of this may be sent to states/UTs
- XIV. Some of the state/UT officials shared that they experienced difficulties in getting their ECCE curriculum translated into various local languages. It was discussed that first of all, the main ECCE curriculum should be printed and made available at all AWCs and further efforts should be made to get it translated into the major local languages.
- XV. Keeping in view the involvement of development partners in development/implementation of ECCE curriculum in States/UTs, it was suggested that their assistance may be availed within the approved parameters of ECCE rollout plan/training strategy of MWCD, Govt. of India with approval of the competent authority.

curriculum. Keeping this fact in view, it was suggested that some provision for development of teaching learning materials need to be made and provided at AWC level for use by AWW. It was felt by Nodal to meet any contingent expenditure on ECCE including preparation of TLMs.

- VI. Many state officials reported that the funds for organisation of ECCE day has not been received from MWCD, Govt. of India and requested that MWCD should be apprised on the matter for kind action for release of funds.
- VII. During the deliberation of the Review Meet, it was learnt that part of the funds approved for PSE Kit was used for printing of some essential ECCE materials. Such initiatives should be discouraged in the interest of
- VIII. It was suggested that while imparting training on ECCE, care should be taken to ensure uniformity in the training content, methodology and duration as per the approved training strategy.
- IX. It was suggested to impart training to the AWHs on ECCE so that their services can also be utilized for implementation of ECCE at AWCs.
- X. The training for ECCE Coordinators is essential for effective implementation of Annual ECCE curriculum. Therefore, provision of training of ECCE Coordinators should be considered and approved by MWCD.
- XI. In order to strengthen knowledge, understanding and skills of State
   Level Master Trainers (SLMTs) already trained by NIPCCD, it was

 In order to understand and benefit from the Annual ECCE Curriculum developed by various States/UTs, it was suggested that every State/UT has to upload their details of Annual ECCE Curriculum, Workbook, Child Assessment Card, and all guidelines relating to implementation of ECCE Curriculum in their respective website.



- It was also suggested that innovative practices adopted by States/UTs in development/implementation of ECCE Curriculum along with success stories/case studies should be shared with NIPCCD so that these are uploaded in the website for wider dissemination and use by other states/UTs.
- III. MWCD, Government of India has approved the budgetary provision vide letter dated 9 January, 2015 for training of AWWs with the assumption that AWWs need not to stay at training venue and therefore, there is no budgetary provision for their stay. Nodal Officers were of the view that AWWs in some cases, leave the training venue early since there was no provision for their stay at the training venue. Therefore, it was suggested that apart from this non-residential training provision, budgetary provision for residential training of AWWs may be approved by MWCD for use by the States/UTs as per their need based requirement.
  - IV. Some States/UTs experienced problems for getting ECCE essential materials printed due to lack of funds. Even some state officials mentioned that provision for printing of essential ECCE materials submitted in APIP (2016-17) has not been considered/approved by MWCD. Funds for printing for ECCE materials need to be approved/released early in the interest of ECCE.
    - V. The need for development of Teaching Learning Materials (TLMs) at AWC level was discussed for effective implementation of ECCE Curriculum. It was also discussed that at least two teaching learning



Infrastructure:- 16,700 out of 35,700 AWCs are functioning in own & rent-free buildings- 1,592 AWC Buildings are under construction and 1651 buildings are constructed.

#### **Uttar Pradesh**

- In 2014-15, pre school kit distributed at AWCs.
- State ECCE council constituted in Aug., 2016 (letter no. 2531/60-2-16-2/1(75)/09) and Meeting planned in this year.
- In SLMT training by NIPCCD, Lucknow, two participants from each district participated. DLMT shall be easily organized with such huge trained personnel upon availability of fund/with support of NIPCCD, Lucknow.

#### **West Bengal**

- Status of Staff/ ECCE Coordinators at State/District Level-Proposal given in AWP&B but fund not received
- Fund for continuing AWW training for approved budget of 30000 head for 2016-17 is not received till now.
- Fund for ECCE day, Printing of Curriculum, Activity Book, Assessment Card is not received in last three years.
- Fund for ECCE Coordinators is not approved till now

## 6. REVIEW MEET RECOMMENDATIONS

Keeping in view the problems and challenges experienced by the States/UTs as well as the discussions held in the Review Meet, the following recommendations are made in order to strengthen implementation of Annual ECCE Curriculum in various States/UTs.

- Total fund sanctioned by GOI for Training of ECCE (vide letter, No. ECCE-2/2015/ECCE, dated 29<sup>th</sup> January 2016) is Rs. 40.64 (90% Share) lakhs but only 1<sup>st</sup> Instalment amounting to Rs. 10.16 lakhs is received by the State.
- Total fund sanctioned by GOI for Printing of ECCE Curriculum, Activity Book and Child Assessment Card is Rs. 21.83 Lakhs (90% Share).
- Till now we have not received any fund for printing purposes.

#### **Tamil Nadu**

- In line with National ECCE Council, State ECCE Council has been constituted to strengthen and mainstream the ECCE Sector, vide
   G.O. (Ms) No.57, SW & NMP Department, Dated: 27.11.2014.
- Spade work of nominating the members to the Council has been done and the Council meeting will be convened very shortly.
- As per Government of India guidelines, fixed monthly ECCE Day is being organized on 19<sup>th</sup> of every month to the tune of Rs.5.44 crores (@ Rs1000/- per AWC/Annum). Fund not received from Govt. of India for the year 2015-16, however through Community participation, ECCE day is observed at AWCs.
- Timely release of ECCE Training Funds from GOI is very much essential.
- Vacancy As a strategy, adolescent girls and community are involved.
- Continuous capacity building measures for all field functionaries is a must – As a convergence initiative tie ups with UNICEF/SSA are facilitated upon.

#### Telangana

- Status of State ECCE Council Pending at State Govt.
- Status of availability of ECCE coordinators Proposal sent to GOI.



batches of AWWs could be covered. Fund had to be scrounged from other sources to counteract the budgetary deficit in order to train all the batches. It would be appreciated if fund could be made available as soon as possible.

 The 1<sup>st</sup> Phase Training on ECCE has been completed in December, 2016. The 2<sup>nd</sup> Phase will have to be conducted soon. It would be really helpful if GOI could release adequate funding.

#### Odisha

- DSWOs and CDPOs also need to be trained on ECCE as they will monitor the ECCE program
- Inadequate fund in ECCE training roll out
- ECCE activities for under 3 years children are not focused

#### **Puducherry**

- Staff scarcity especially ICDS Supervisors
- Funds not released in time
- Anganwadi workers are being engaged in various Government programme

#### Sikkim

- State ECCE Council is constituted vide Notification No. 332/SJE&WD/W&CDD/14-15, dated 20/9/2014 but Meeting of State ECCE Council is yet to be held.
- Proposal for ECCE Coordinators for State/ District and Block level is taken up in APIP of 2017-18.
- The major Gaps and Problems creating hindrances in successful implementation of ECCE in the State is non release of fund by GOI.

- Lack of awareness among the society regarding importance of ECCE.
- ECCE Staff: Proposal Submitted to Govt of Kerala for the creation of posts; Proposal is being considered in ICDS Mission Executive Committee and made recommendations for its posts

#### Karnataka

- The activities involved in the roll out of curriculum in 204 ICDS
   Projects in Karnataka being started on war footing.
- In order to roll out ECCE curriculum in Karnataka, NIPCCD has conducted sensitization workshop for nodal officers dealing with ECCE in the state and 13 State Level Master Trainers are ready to train District level Master Trainers. The tentative training schedule is planned to train DLMTs in a total of 90 batches in Phase 1 and Phase 2 (which includes 5 days residential training each). These DLMTS to train 65911 Anganwadi workers in 1613 batches of 12 days non residential training in 3 phases.

#### Lakshadweep

- Department already conducted 1<sup>st</sup> and 2<sup>nd</sup> phase DLMTs Training.
   Also conducted the 1<sup>st</sup> phase training to Anganwadi Workers by DLMTs. But the problem is that printed materials have not been received on time. This leads to delay of proper functioning of Anganwadi Centers as per ECCE guideline.
- Not recruited separate staff for Implementation of ECCE Curriculum.
   The staff of ICDS Projects and departmental staff coordinate for implementation.

#### Mizoram

GOI has released only the first installment of fund for ECCE Training.
 This fund could cover the 1<sup>st</sup> phase training cost of all 4 batches of DLMTs. However, training cost for only 23 batches (approx) out of 56

#### Haryana



- No contractual staff under ECCE at different levels have been appointed as no funds have been released for the post of contractual staff in APIP 2016-17.
- State Government sought clarification vide letter dated 16-6-2016 whether to fill up these posts or not. But no response has been received yet.
- No funds have been allocated for celebration of ECCE day in APIP of 2016-17.
- It is status symbol to send children in the so called private nursery schools instead of Anganwadi Centres.

#### J&K

- General understanding of ICDS centre as food centre.
- Lack of community participation.
- Lack of regular training of CDPO, Supervisor, and Anganwadi worker.
- Non availability of ECCE curriculum at AWC.
- Unrest in valley.
- Geographical challenges
- Lack of adequate space for ECCE activities.
- Motivation of ICDS worker and helper
- Lack of sufficient ECCE materials
- Research and monitoring.

#### Kerla

- Growth of Kinder Gardens in private sector
- Lack of infrastructure facilities including pucca building out door play space etc

#### Bihar



- Fund for printing of ECCE Curriculum & ECCE day is yet to be received.
- Fund for training not adequate.
- Non availability of staff/coordinator for ECCE at all levels.

#### Gujarat

- Contextualized ECCE Curriculum developed Approved by State
   ECCE Council on 18/10/16 No budget provision for printing the same
- Theme based Activity Bank for Anganwadi workers completed No budget provision for printing the same
- Printing and supply of developmental assessment card for each child
   (3 6 years) Budget not approved in APIP -16 -17
- Age specific Activity Book for Children Developed -Budget not approved for printing in APIP -16 -17
- Training Module on ECCE for Anganwadi workers Developed and photocopy used for training DLMTs

#### **Himachal Pradesh**

- Reduction in number of 3-6 years children in the AWCs.
- Lack of facilities / minimum infrastructure standards in ECCE Centres run by private organisations/ individuals.
- Lack of mechanism available to regulate mushrooming of ECCE Centres in the Stare.
- Lack of well educated and trained staff in ECCE Centres.

#### **Arunachal Pradesh**



- Many of the Anganwadi Workers are semi-literate and therefore, they are facing difficulties to implement the ECCE curriculum in Anganwadi Centres. So, the Anganwadi Workers should be given more intensive training on ECCE curriculum and also Refresher Training periodically.

- The State has completed e- tendering process for printing of ECCE curriculum and child Assessment Card
- Activity book and its guidelines have been developed and under process for approval

#### Mizoram

- The ECCE Curriculum and Activity Books have been printed and distributed to all AWCs. Also, a companion book for ECCE Curriculum (Naupang Thawnthu & Nursery Rhymes) has been developed and distributed to all AWCs.
- The State ECCE Council was constituted on 15/5/2014 but no meeting has been held so far.
- ECCE Coordinators have just been recruited. Key ICDS functionaries will also pool their ideas and thoughts and come up with suggestions which would be considered for formulation of essential guidelines on ECCE.

#### Lakshadweep

- The UT has followed the curriculum of Kerala
- Already conducted <sup>1st</sup> and <sup>2nd</sup> phase training of DLMTs (Lady Village Extension Officers and Gramasevikas, staff at ICDS Project)
- Also conducted the <sup>1st</sup> phase training of Anganwadi Workers by DLMTs.
- Not received the printed materials on time that leads to delay of proper functioning of Anganwadi Centers as per ECCE guideline.
- Not recruited separate staff for Implementation of ECCE Curriculum.
   The staff of ICDS Projects and departmental staff coordinate for implementation.

  - DLMT training would be conducted by NIPCCD due to non-availability of training infrastructures. The Nodal Officers stated that a request letter would be sent to NIPCCD for organization of the above training programme at NIPCCD, Regional Centre, Lucknow.

- 4.1 In the Overview of ECCE Session, details of guidelines developed and strategy made by the Ministry of Women and Child Development, Govt. of India for development of Annual ECCE curriculum as well as action required/taken by States/UTs for development and transaction of ECCE curriculum keeping in view provision made under the National ECCE Policy, National ECCE Curriculum Framework and Quality Standards for ECCE were discussed. Details of the training strategy developed for providing training to State Level Master Trainers (SLMTs), District Level Master Trainers (DLMTs) and AWWs were also discussed with the present status with the required steps to be taken by the States/UTs for strengthening training under ECCE.
- 4.2 As per the terms and reference intimated to the States/UTs for sharing the ECCE implementation, Nodal Officers of States/UTs made their presentations on different aspects of ECCE implementation. The details of the presentations made by the State/UT officials are at Annexure-III. The State/UT wise status of training of DLMTs/AWWs, availability of Annual ECCE curriculum, workbook/activity book, Child Assessment Card, supply of ECCE Kit for 2016-17, availability of contractual ECCE staff, development of monitoring indicators on ECCE implementation and constitution of State ECCE Councils and their meetings are placed at Annexure-IV.
- 4.3 The brief of the discussions held in the Review Meet during presentations made by officials of States/UTs on different aspects of implementation of Annual ECCE curriculum are as stated below:

### 4. ORGANISATION OF THE REVIEW MEET

The Inaugural Session of the Review Meet was held in the forenoon under the Chairmanship of Shri K.B. Singh, Director, NIPCCD. The Session started with the welcome address by Dr. K.C. George, Joint Director, Training Division, NIPCCD. Dr. George extended a warm welcome to all the state officials as well as Director, NIPCCD in the Review Meet followed by self-introduction of all present in the Meet. The Joint Director, Training Division briefed the delegates about the need and importance of the Review Meet keeping in view the rolling out process of ECCE curriculum in the country. The Director in the Inaugural Address, first of all, reviewed the status of development of ECCE curriculum in the country and was happy with the responses of the state officials on status of curriculum developed by all the States/UTs. He emphasized the need and importance of ECCE curriculum and its transaction at all AWCs for all round development of children. He reiterated the importance of early 1000 days in child life for optimal brain development. The Director gave importance to local language/mother tongue for transaction of age appropriate and developmental appropriate ECCE curriculum. He explained that school readiness activities are of great importance for meaningful learning of school activities at primary classes for reducing school dropout rates. He made a request to all the State/UT nodal officials to share their innovative strategy/best practices in respect of implementation of ECCE curriculum for uploading in the website for wider dissemination in the country. He also interacted with the state officials about the monitoring strategy developed in their States/UTs in respect of implementation of ECCE curriculum. The indicators emerged from the interaction were enhancement of attendance of children at AWCs, development in children, children enrolled at primary school and confidence building in AWWs. The Director categorically pointed out that there should not be any indicators to assess the formal learning in children. He also suggested that some indicators may be in place to improve the nutritional status

#### 2. STRATEGY FOR MEET ORGANISATION



Keeping in view the important objective of the Meet to review the status of implementation of Annual ECCE Curriculum in the States/UTs, the States/UTs were requested to depute the Nodal Officer dealing with ECCE to participate in the Review Meet. The States/UTs were also requested to advise the deputed Nodal Officers to make a brief presentation on the various aspects of ECCE implementation so that need based review is held for the purpose of training and effective implementation of Annual ECCE Curriculum. These aspects of presentation are as stated below.

- Status of availability of ECCE Curriculum, Work Book/Activity Book, Child Assessment Card and ECCE Kit at AWCs and their replenishment policy and guidelines for use;
- Status of State ECCE Council (Date of constitution/dates of meetings, major decisions for ECCE implementation);
- Status of availability of staff/ECCE Coordinators at state/ district/block level;
- Guidelines developed on implementation of ECCE by state/UT in general and guidelines on learning corners, portfolio maintenance, involvement of VHSNC/ALMSC in implementation and monitoring of ECCE, toy bank, monitoring indicators on ECCE etc. in particular;
- Implementation status of Annual ECCE Curriculum in States/UTs highlighting the challenges faced and strategy adopted/innovative steps taken to address the problems;
- Status of training of DLMTs and AWWs on implementation of Annual ECCE curriculum; and
- Comments of States/UTs on Law Commission Report (Report No.259) on ECCE.

#### 3. PARTICIPANTS

The Review Meet was attended by 42 participants from 25 states/UTs including 8 faculty from NIPCCD. The list of these participants is placed at Annexure-I. It may be mentioned that keeping in view the role of NIPCCD, Regional Centres in facilitation process of implementation of Annual ECCE Curriculum in states/UTs, under their jurisdiction, one faculty dealing with ECCE Cell from each Regional

were requested to give utmost priority to plan for the training and supportive supervision of different functionaries so that the Annual Curriculum begins to be transacted in the AWCs for the benefit of the children. Accordingly, a training strategy was developed for sensitization of senior officers of States/UTs, training of State Level Master Trainers (SLMTs), training of District Level Master Trainers (DLMTs) and AWWs on implementation of state specific Annual ECCE Curriculum. The First Phase of training consisting of 8 courses was conducted at NIPCCD Headquarters and its four Regional Centres. It may be mentioned that a total number of 312 SLMTs of 33 States/UTs have been trained by NIPCCD in the First Phase. The Second Phase Training of SLMTs was to be conducted once they organise training of District Level Master Trainers (DLMTs). As on 23.02.2017, 112 SLMTs from 20 States/UTs were trained under the Second Phase.

- 1.4 In order to facilitate effective implementation of Annual ECCE Curriculum in various States/UTs, Stock Taking Review Meets for Rolling out of ECCE Curriculum were scheduled by NIPCCD. Two of these Review Meets were conducted at NIPCCD Regional Centres, Guwahati and Indore on 6.5.2016 and 22.08.2016 respectively. The present Meet was held at NIPCCD, New Delhi on 23<sup>rd</sup> February 2017 with the following objectives:
  - Review the implementation of Annual Contextualised ECCE Curriculum in the States/UTs;
    - Share the experiences of challenges faced by the States in implementation of the ECCE Curriculum;
    - Refresh the participants about the philosophy, principles and components of the National ECCE Policy, Curriculum Framework and Quality Standards;
    - Familiarize the participants-with the State/UT specific ECCE Curriculum and its roll out Plan across the States/UTs; and
    - To discuss about the possible solutions strategies to meet the challenges and effectively roll out the annual contextualized curriculum in the States/UTs.

- 1.2 ICDS scheme is one of the world's largest and most unique programmes of Early Childhood Care Education and Development (ECCED) and implemented through a network of 14 lakh approved Anganwadi centres/Mini-Anganwadi centres (AWCs) at the community level in 7076 approved projects in the country. The programme adopts a multi-sectoral approach to child development, incorporating health, early education and nutrition interventions. Achievement of two important objectives of ICDS is dependent on successful implementation of its Early Childhood Care Education and Development (ECCED) component. This is one of the most important components of the ICDS and in many ways can be considered to be the backbone of the programme. The ECCED component of the ICDS would ensure a significant input for providing a sound foundation for cumulative lifelong learning and development.
  - 1.3 Adoption of National Early Childhood Care and Education (ECCE) Policy by Government of India in September, 2013 has been a major landmark in strengthening ECCE in the country. This National ECCE Policy advocated promotion of developmentally appropriate practices of ECCE through a multiprometromation of laying down quality standards; developing curriculum framework; provision of appropriate and adequate play materials; conducting programme assessment and child assessment etc. Accordingly, National ECCE Curriculum Framework, Quality Standards for ECCE and age appropriate Assessment Cards were prepared, notified and circulated to all States/UTs by Ministry of Women and Child Development (MWCD) for adherence and preparation of action plan for implementation in States/UTs. Further, MWCD developed a Roll-Out Plan and sent to all States/UTs on 21.4.2014 for implementation of Annual Contextualised ECCE Curriculum. In this Roll Out Plan, apart from development and supply of essential ECCE materials, all the States/UTs
