A. INSTRUCTIONS TO BIDDERS

- 1. National Institute of Public Cooperation and Child Development, hereinafter referred to as 'NIPCCD' intends to identify a firm for provision of Smart Class Room for its' newly set up Regional Centre at Sector 79, SAS Nagar, Mohali, Punjab.
- **2.** Sealed tenders are invited for the above purpose under two bid system viz. technical bid and financial bid.
- **3.** The Tender Form may be obtained from Room No. 202, NIPCCD, 5, Siri Institutional Area, Hauz Khas, New Delhi-110016 on any working day on request and payment of Rs.200/- within 15 days from the publication of the advertisement. However, the tender form may be downloaded from the website (www.nipccd.nic.in) of the Institute at free of cost.
- **4.** The specification of the job is as per mentioned in the tender document.
- 5. The bidders must fulfil the criteria mention in the terms and conditions mentioned in the tender document.
- 6. A copy of each of the following documents must be submitted with the technical bid as a proof:
 - i. PAN of the firm
 - ii. GST Regn. No.
 - iii. Last three years' Balance Sheets duly certified by a Chartered Accountant;
 - iv. Income Tax Return for last three years;
 - v. Certified copy of proof of turnover Rs.1.0 crore in any financial year during last 3 years
 - vi. The manufacturer/bidder should furnish the information supported by Purchase order or Work done certificates from the concerned department as specified in the tender document
 - vii. The manufacturer/bidder should be in the business in India for more than 4 years as on 31-3-2018 as specified in the tender document
 - viii. The manufacturer/bidder should have technically qualified staff and a list of the same to be attached
- 7. Tenders should be accompanied by earnest money of Rs.1,00,000/-(Rupees One Lakh only) in the form of A/c payee bank demand draft in favour of National Institute of Public Cooperation and Child Development and payable at New Delhi failing which tender shall not be considered. Firm registered with certain Body/Agency may be waived of Earnest Money subject to providing necessary certificate with the technical bid.

- 8. The bidder should submit their complete bids in two separate sealed envelopes i. e. Envelope-I for technical Bid and should be marked as "<u>Technical Bid</u>" and Envelope-II for financial bid and should be marked as "<u>Financial Bid</u>". These two envelopes should be placed inside a third envelope duly sealed and super-scribed "<u>Tender for Provision of Smart Class Room for NIPCCD Regional Centre, Mohali</u>" should be dropped in the Tender Box in Room No.202 at second floor of the Institute at 5, Siri Institutional Area, Hauz Khas, New Delhi-110016 <u>not later than 3.00 p.m. on 29.11.2018</u>. Bids received after the prescribed date and time shall not be considered.
- **9.** The Technical Bid will be opened by a committee constituted by the Institute on **the same day at 3.30 p.m.** in the presence of the bidders/ their representatives, if any.
- **10.** Technical bids found complete in all respect will be evaluated by an Evaluation Committee constituted by the Competent Authority of the Institute. It may be noted that incomplete technical bid will be treated as rejected and will not be evaluated.
- **11.** Financial bids of only those bidders will be opened who are found qualified/eligible after evaluation of Technical Bid by the Evaluation Committee.
- **12.** The successful bidder will be required to deposit performance security equivalent to 10% of the bid value of contract in the form of a bank demand draft or Deposit at Call of Nationalized Bank and payable at New Delhi in favour of NIPCCD within 10 days of award of the contract. The same will be released after the expiry of the defective liability period.
- **13.** The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all the information required as per Bid Documents or submission of the Bids not substantially responsive to the Bid Documents in every respect will be at the Bidder's risk and may result in rejection of the Bid.
- **14.** The Bid Security may be forfeited:

If the Bidder withdraws his Bid during the period of Bid validity specified in the Bid Form OR

In the case of successful Bidder, if the Bidder fails to sign the contract in accordance with tender clause.

OR Fails to furnish ISD/performance security in accordance with tender clause OR

Fails or refuse to honor his own quoted price for all/any item.

Note: In the above cases the bidder will not be eligible to participate in the Tender for one year from the date of issue of Letter of Intent.

15. The cutting, over writing, erasures etc. if any in the Bid made by the Bidder shall be signed and stamped.

16. Evaluation

Bid should be submitted in three envelopes as mentioned above.

- (I) NIPCCD shall evaluate the Bids to determine whether they are complete, whether any computational errors have been made, whether documents have been properly signed and stamped, whether Bids are generally in order.
- (II) Prior to detailed evaluation, NIPCCD will determine the substantial responsiveness of each Bid to the Bid Document. A substantial responsive Bid is one, which confirms to all the terms and conditions of Bid Document without material deviation. A Bid determined as substantially non-responsive will be rejected by NIPCCD.
- (III) NIPCCD shall evaluate in detail and compare the substantially responsive Bids and comparison of Bids shall be on the quoted rate inclusive of all levies, taxes and charges etc. in the price schedule (BOQ) of the Tender Document.
- (IV) In case of any discrepancy between the rates quoted in figures and words, the rate on which the amount has been worked out shall be taken as correct. If the amount of an item is not worked out by the bidder in words shall be taken as correct. Where the rates quoted by the bidder in figures and in words tally but the amount is not worked out correctly, the rates quoted by the contractor will be taken as correct and not the amount.

17. Award of Contract

- (I) NIPCCD shall consider placement of Letter of Intent to lowest Bidder whose offer has been found technically, commercially and financially accepted. The Bidder shall <u>within 3 days</u> of issue of Letter of Intent, give his acceptance along with performance security.
- (II) NIPCCD reserves the right to terminate a contract by giving 07 days' notice and without assigning reason thereof.

18. Period of validity of Bids

The tender for the works shall remain open for acceptance for a period of 7 (Seven) days from the date of opening of tender. The Earnest Money will be forfeited in case the bidder withdraws his tender during the validity period or in case he changes his offer to his benefits which are not acceptable to NIPCCD. The validity period may be extended on mutual consent.

- **19.** The tender shall be deemed to have gone through the various conditions and clauses of the tender and visited the site before quoting their rates. Once they make an offer for this work, No claim whatsoever shall be entertained on this account.
- **20.** Canvassing whether directly or indirectly in connection with tenders is strictly prohibited and the tenders submitted by the bidders who resort to canvassing will be liable to rejection.
- **21.** Notwithstanding the above, Director of the Institute shall have right to reject any tender without giving any reasons thereof.

C. Technical Eligibility Criteria

- The place of the work: NIPCCD, Regional Centre, Mohali, Institution No. 87, Behind Police Housing Board Headquarters (Under Construction), Sector – 79, S.A.S Nagar, Mohali, Punjab
- 2. The manufacturer/bidder should not be associated or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the purchaser to provide consulting services for the preparation of the design, specification, and other documents to be used for the procurement of the goods to be purchased under this invitation of tenders.
- 3. Manufacturer/bidder shall not be under any declaration of ineligibility for corrupt and fraudulent practices issued by any state Government / GOI / Union tertiary. The manufacturer/bidder should not be a defaulter of any financial institute or Bank and their assets should have never been put on auction for recovery of debts.
- 4. The manufacturer/bidder should be in the business in India for more than 4 years as on 31-3 2018. This should be supported by the certificate of registration issued under the companies act by a competent authority.
- 5. The manufacturer/bidder should have the turnover of Rs.1.0 crore in any financial year during last 3 years upto 2017-18. This should be supported by audited balance sheet of the company and duly audited by the Chartered accountant or Turn Over Certificate from Chartered accountant.
- 6. The manufacturer/bidder should have executed / Implemented work order at any Govt. Institution/Central and State Universities /IIT/NIT/PSU/Research Organisation.

It should be having at least two orders minimum of Rs. 25 lakh or a single order of Rs.50 Lakh. The bidder should furnish the information supported by Purchase order or Work done certificates from the concerned department.

- 7. The manufacturer/bidder should submit catalogue with complete technical details with Make and Model for technical evaluation purpose. Bids without Catalogue or with incomplete information will be rejected.
- 8. There should be no complaint against the Manufacturer/Bidder for poor performance of the equipment supplied.
- 9. The manufacturer/bidder should submit copy of ITR last three years.
- 10. The manufacturer/bidder should submit copy of PAN and GST No.
- 11. If bidder is supplying the material of a particular brand/manufacturer, copy of valid Authorized Dealer Certificate in absence of which his bid will be rejected.
- 12. The Manufacturer should have certification as per the International Standards.
- 13. The Bidder should have Authorization certificate from Manufacturer for this Tender with Tender No. mentioned in it for Software License, Podium, Visualizer and Interactive Flat Panel.
- 14. The manufacturer/bidder shall be ready for demonstration of the product quoted on short notice as per the tendered specifications.
- 15. The manufacturer/bidder has to quote all the products as per the Tender.
- 16. Director of the Institute is the final authority to judge the tender and has the right to accept or reject any bid without assigning any reason.
- 17. Technically qualified bidders should demonstrate the product functionality during the installation and training.
- 18. The Bidder should undertake to provide after sale service whenever needed by the purchaser.
- 19. Financial Bid of only Technically Qualified Bidders will be opened.
- 20. Manufacturer/bidder who will secure 75% marks out of 100 marks will be Technically Qualified Bidders. The following will be the parameters for marks:
 - i) The manufacturer/bidder should submit copy of ITR last three years up to Financial Year 2017-18: (Total Marks: 25).
 - ii) The manufacturer/bidder should submit copy of PAN and GST No.: (Total Marks: 5).
 - iii) The manufacturer/bidder should furnish the information supported by Purchase order or Work done certificates from the concerned department as specified in point 5 above: (Total Marks: 10).
 - iv) The manufacturer/bidder should be in the business in India for more than 4 years as on 31-3-2018 as specified in point no.3 above: (Total Marks: 20).
 - v) The manufacturer/bidder should have technically qualified staff and a list of the same to be attached: (Total Marks: 10).
 - vi) Copy of Authorization certificate Manufacturer/Authorization Certificate/ Licence from Manufacturer/Developer (in case of Software) to be attached: (Total marks 15).
 - vii) Turnover Certificate as specified in point 4 above: (Total marks 15).
- 21. Bidder has to quote rate for three units i.e. Class Room-1, Class Room-2 and Conference Hall separately.
- 22. The criterion for selection of lowest bidder is on total cost basis and not on unit wise.

23. Payment Procedure

100% payment will be released after satisfactory completion of the work.

24. Defective Liability Period:

The defective liability period is one year from the date of completion/functioning of the smart class room. Any defect in any item discovered and brought to the notice of the agency forthwith shall be attended to and replaced with a new one of the same specification by him at his own cost and expense. In case the agency fails to carry out these replacements, the same may be without prejudice to any other right or remedy available, be got replaced by NIPCCD at the cost and expense of the agency. If the agency fails to bear the same, the same will be recovered from the performance guarantee.

- **25. Tax Deducted at Source:** Taxes will be deducted at Source as per existing provision of Income Tax and GST Rule/Act.
- 26. Escalation Payment: Escalation is not payable under any circumstance.
- **27. Delay and Liquidated Damages**: The entire job will be rejected if the same has not been carried out in accordance with the specifications. In case of delay beyond stipulated time, necessary recovery will be made from the bills submitted by the agency. Any sum of money due and payable to the agency under this contract may be appropriated by the NIPCCD and set off against any claim of the NIPCCD. If the agency fails to complete the work within stipulated period prescribed, the NIPCCD shall be entitled to recover 0.50% of the value for each week of delay or part thereof for a period upto 10 weeks and thereafter the rate of 0.70% of the value for each week of delay or part thereof for another 10 weeks of delay provided the total amount of compensation shall not be exceed 10% (ten percent) of the awarded value of contract.
- **28. Indemnity against Patent Rights:** The agency shall fully indemnify the NIPCCD from and against all claims and proceedings from or on account of any infringement of any patent rights, design, trademark or name or other protected rights in respect of any manufacturing equipment machine work or material used for in connection with the works or temporary works.
- **29. Law Governing the Contract:** This contract shall be governed by the Indian Laws from time to time being in force.
