INSTRUCTION TO BIDDERS

1. Eligible Criteria:

- a) The bidder should be a registered partnership firm/Company under the Companies Act, 2003 and also register with GST Department. Self attested copy of Registration of the firm/incorporation of the company, TIN No., PAN No. GST No. should be enclosed and preferably registered as seller with Government e-Market.
- b) The bidder shall have its registered office/Branch Office/Service Centre in Guwahati and shall submit a self-attested proof of the same.
- c) Bidder should have completed at least three work orders amounting to Rs.3 lakhs each pertaining to supply and installation of CCTV and other accessories during last two years up to 31.3.18.

2. Submission of the Bid:

- a) The bid shall be submitted in the following manner as mentioned below:
 - Envelope-I: shall contain Technical bid along with relevant documents. The document duly stamped and signed on each page as token of acceptance of all terms and conditions of the tender in a sealed envelope.
 - Envelope-II: shall contain Financial Bid with relevant documents and the same shall be duly signed and stamped on each page as token of acceptance of all terms and conditions of the tender in sealed envelope. The completed bids may be submitted in person or alternatively by registered post/speed post so as to reach by the time and date stipulated for receipt of Bid. Bids received after due date and time shall not be accepted.

3. Earnest Money Deposit (EMD)

- a) All bids must accompanied by Earnest Money for an amount of Rs.10000/- (Rupees ten thousand only) (except where legally exempted) in the form of D.D. issued by any scheduled/nationalized bank of India drawn in favour of NIPCCD.
- b) In case the Bidder claims for waiver of EMD, the bidder shall provide documentary proof of being registered with the Central Purchase Organization or Micro and Small Enterprises as per Rule 170 of GFR 2017, of Govt. of India.

- c) Bid without EM or documentary evidence for waiver of the same as indicated above shall be summarily rejected as non-responsive.
- d) Unsuccessful bidder's EMD will be returned within 30 days from the date of placement of order to the successful bidder.
- e) The successful bidder's EMD will be released along with the final payment to it on completion of the work.
- f) No interest is payable on the EMD.

4. Period of Bid Validity:

Bids shall remain valid for 90 days from the date of bid opening. Any bid valid for a shorter period than the period specified shall be rejected as non-responsive. In exceptional cases, NIPCCD may seek extension of the Bid validity period, where the process could not be completed for any reason.

5. Last date & Time for receipt of Bids:

The last date for receipt of Bids is 13.09.2018 till 3.00 p.m. Technical Bids will be opened on the same day at 3.30 p.m. Date of opening of Financial bids will be intimated separately to the technically qualified bidders.

6. Award of Contract:

- a) NIPCCD shall issue PO to the L1 bidder, prior to the expiry of the period of Bid validity period.
- b) After award of contract, the job must be completed within a month.
- c) The liability of the successful bidder to perform the job will commence from the date of notification of Award. The completion period shall be counted from the date of 'Notification of Award of Job.

7. Performance Security:

The successful bidder will have to deposit performance security of 7% of contract value within seven days of award of work. Performance security may be deposited in the form of Demand Draft from any commercial bank or online payment in an acceptable form. No interest will be paid on performance security.

8. Payment Terms:

100% Payment will be paid to the bidder after successful delivery, installation, testing and commissioning of the supplied materials at desired location at NIPCCD, Guwahati. The payment shall be made after submission of invoice in triplicate in the name of Regional Director, NIPCCD along with the satisfactory installation and commissioning report duly signed by the concerned officer of the authority.

9. General Terms & Conditions:

- a) Unit price must be mentioned in INR inclusive of transaction cost.
- b) OMAF (Original Manufacturer Authorization Form) of camera, NVR should be submitted along with the technical bid.
- c) Product Quoted (CCTV/NVR and software if any) should be of same make.
- d) The requirement/installation of CCTV Cameras may increase or decrease as per the needs of the department and the bidder should have the capacity to provide more CCTV cameras/accessories as and when required by NIPCCD for installation.

1. Scope of Work:

- a) Installation of 17(13+4) cameras at desired locations covering the entrance to all the floors.
- b) The equipment/materials should be under two years comprehensive warranty from the date of successful delivery & installation.
- c) All cameras should be IP based.
- d) The IP based Video Surveillance system shall be a Hybrid System with distributed architecture having control station at the administrative and Hostel Building.
- e) A network, comprising a 16-port switch connected with CAT6, shall be laid for transmission of signal from cameras to the Control Room.
- f) After commissioning the Video surveillance system, the same shall be demonstrated for all its capabilities to the relevant user department to make them familiar with the system.

2. Warranty period:

All the equipment supplied against this RFP shall have warranty for a period of two years from the date of installation and commissioning.
